Grant Guidelines

The following information is intended to clarify our grantmaking process and help you discern whether the project for which you seek funding is in alignment with the Foundation's priorities.

Grantmaking Overview

The Foundation funds projects that benefit animals and nature.

If you are interested in applying for a grant, we ask that you reach out to one of our program officers to discuss your work. Please do not submit a proposal without first discussing your project with us; this will save your organization time and resources.

If a proposal is invited, you will receive a link to our Grantee Portal, which will give you access to our grant application. Deadlines for grant applications will be announced at the time a proposal is invited.

Funding Priorities by Program Area

Animal Protection

To be considered for a grant, your organization must qualify as a 501(c)(3) public charity and fall into one of the following funding categories:

- Direct care and services to horses, donkeys, and mules in New Mexico
- Ending the use of animals in invasive research in the United States
- Protecting vulnerable animals in New Mexico

Cats & Dogs

Requests for funding are considered from 501(c)(3) public charities and qualified governmental units. The Foundation awards grants to organizations that:

- Advocate for the protection of cats and/or dogs in New Mexico
- Provide direct care and services to cats and/or dogs in New Mexico

Pollinators

Organizations applying for funding must qualify as 501(c)(3) public charities or work with a fiscal sponsor. We fund the following through our Pollinators Program:

- Efforts to reduce and/or eliminate pesticide use in the American Southwest
- Native pollinator habitat preservation, restoration, and/or creation in New Mexico
- Native pollinator species protection in the American Southwest
- Urban forestry and agroforestry projects in New Mexico

Wildlife

To be eligible for consideration, your organization must be a qualified 501(c)(3) public charity or work with a fiscal sponsor, and the program/project for which you seek funding must fall into one of the following funding categories:

- Habitat preservation and/or restoration work in New Mexico; specifically in the Rio Grande, Pecos, and Lower Colorado River basins
- Species protection in Arizona, Colorado, New Mexico, and Utah

Generally, We Do Not Fund...

- Animal sanctuaries/shelters/rescues located outside of New Mexico, unless there is a strong partnership with a local organization to significantly help animals in New Mexico
- Deficit financing
- Endowments
- Energy-related programs
- Environmental/social justice programs
- Grants to individuals
- Honeybee projects
- Indirect costs, overhead, or facilities administration to academic institutions/universities
- Outdoor recreation programs
- Re-grantmaking programs
